NOTICE OF SOLICITATION

Notice is hereby given that pursuant to the provisions of N.J.S.A. 19:44A-20, New Jersey Pay to Play, and other legislative enactments, more specifically Chapter 271 of the laws of the State of New Jersey, the West Deptford Township Board of Education located at 999 Kings Highway, West Deptford, New Jersey 08066 is seeking proposals for professional services for **ARCHITECT** to be provided to the West Deptford Township Board of Education for the period July 1, 2024 to June 30, 2025, with possible two (2) one-year extensions for the 2025-2026 and the 2026-2027 school years, at the option of the Board of Education.

All proposals must be received by the West Deptford Township Board of Education School Business Administrator/Board Secretary **no later than Thursday, April 18, 2024 at 10:00am** at the Board of Education office located at 999 Kings Highway, West Deptford, New Jersey 08066. If awarded a contract your company/firm will be required to comply with the regulations of N.J.S.A 10:5-31 et. al. and N.J.A.C 17:27 et.al.

MINIMUM REQUIRED INFORMATION/DOCUMENTATION

All proposals for professional service contracts shall include at a minimum the following information/documentation.

1. Organization/Management Structure:

- a. Identify the person who will be primarily responsible for the services required by the Board of Education of West Deptford Township and provide a description of the experience of the primary person with clients/projects and issues similar to those more specifically set forth in this proposal and on behalf of the Board of Education of West Deptford Township.
- b. Identify persons who will serve as back up to the primary person including resumes of all parties.
- c. Number of years in business.
- d. Provide a list of previous Board of Education clients and contact sources.

2. Describe ability to provide services in a timely fashion including a description of your staffing and a description of your familiarity with the services required by the Board of Education of West Deptford Township.

3. Provide a fee structure including the cost of services (hourly rate). Proposal shall detail whether clerical and other overhead costs will be billed separately or included in the hourly labor rate for the architects.
4. Professional Liability Insurance: The provider is to provide, at own expense, a comprehensive general liability insurance policy including professional liability, insuring against any and all claims for bodily injury or death resulting from performance and services by the professionals, staff, and agents. The insurance shall provide not less than \$1,000,000 with respect to injury or aggregate, or may be in such other form as provided by the New Jersey Tort Claims Act, NJSA 59:1-1 et. seq., which shall govern the terms and conditions of any such program. The School District shall be listed as additional insured on the policy.
5. New Jersey Business Registration Certificate: A copy of the New Jersey Business Registration Certificate must be included in the response. *NOTE: In accordance with P.L. 2004, c.57, as a public entity, the Township of Franklin (Gloucester County) Board of Education is required to have this document on hand before entering into a contract with any vendor or company.*
6. Responders must comply with the requirements of P.L. 1975, Chapter 127, NJAC 17:27 Laws Against Discrimination. (See Exhibit A and attachments.)
7. Political Contribution Disclosure: Businesses and vendors making \$50,000 or more in public entity work, shall provide an annual disclosure statement with New Jersey Election Law Enforcement Commission (NJ ELEC) setting forth all contributions made within the past twelve (12) months.

SCOPE OF SERVICES

Pursuant to Title 18A-18A-5(1) professional services are not required to be bid or advertised and the Board is not required to award on the basis of lowest price and will award based on criteria as outlined in this request for proposals. The requests are being made to ensure the District receives the highest quality service at a fair and competitive price.

1. The West Deptford Township Board of Education is requesting proposals from New Jersey licensed architects interested in providing Architectural Services as the Architect of Record for the District. The successful contractor must have a minimum of five (5) years' experience in full architectural services for a New Jersey public school, including the programming, design, cost estimating, preparation of construction documents, reproduction costs, bid development, bid evaluation, construction administration, final inspection, and project acceptance for a New Jersey public entity.
2. The Architect shall work cooperatively with the Board Attorney and Business Administrator in the bidding, award and closeout of projects. The Architect shall assist the Board in recommending professional services, such as engineers and other experts. The Architect must provide a contact phone number for assistance in resolving problems which may arise on an emergent basis and is expected to return such emergent calls within two (2) hours. The professional will also be expected to be available to provide advice to the West Deptford Township Board of Education and its staff during non-business hours including attendance at meetings when requested.

The West Deptford Township Board of Education shall not be bound to use the appointed Architect of Record. The board may obtain competitive pricing through either a RFP/RFQ or

quotation process from other architectural firms for any projects approved by the Board when it is in the best interest of the Board.

MINIMUM QUALIFICATIONS

1. Architect's firm shall have three (3) or more licensed professionals on staff whose major focus and work has been and remains providing professional services to and advising public schools.
2. The firm shall have at least five (5) years' experience in representing public schools.
3. The firm shall designate one (1) professional within the firm who will be assigned to represent the interest of the School District. This individual shall have been admitted and/or licensed in his/her profession and be in good standing.
4. The firm and individuals assigned to work with the School District shall be well versed in all aspects of the School District's operations.

EVALUATION OF PROPOSALS

The School District intends to award a professional services contract for the defined scope of work under the Fair and Open Process in accordance with N.J.S.A. 19:44A-20.4 et seq.

The proposals will be evaluated by a committee of staff and Board Members of the School District based upon information supplied by each Responder to this RFP and the following criteria:

- Ability to meet all minimum qualifications.
- Overall knowledge and familiarity with the needs/operations of the School District.
- Experience of the firm in providing similar services to other public school districts, with special emphasis on experience in New Jersey.
- Qualifications and experience of the professionals.
- Qualifications and experience of the other members of the professional's firm.
- The hourly rates proposed.

SUBMISSION

Proposing firms shall provide evidence that the minimum qualifications are met. Proposals should also include cost details including hourly rates of the individuals who perform services and whether clerical and other overhead costs will be billed separately or included in the hourly labor rate for the attorneys. Proposals shall include a list of public school clients including length of service provided to those clients.

Proposals may be delivered to the above address between the hours of 8:00 a.m. and 4:00 p.m. Proposals must be plainly marked on the outside “**ARCHITECT SERVICES**” and the envelope containing the proposal shall be endorsed on its face with the name of the person, firm or corporation making such proposal. The West Deptford Township Board of Education will not be responsible for the premature opening of any proposal not so marked.

The Board reserves the right to reject any or all proposals and to waive immaterial informalities, or to accept any proposal, which in the opinion of the Board of Education will be in the best interest of the School District. Any deviation from the materials and/or supplies of this proposal will be deemed a breach of contract, unless prior written consent is obtained by the vendor from the West Deptford Township Board of Education’s School Business Administrator/Board Secretary.

P.L. 2005, c.271

(Unofficial version, Assembly Committee Substitute to A-3013, First Reprint*)

AN ACT authorizing units of local government to impose limits on political contributions by contractors and supplementing Title 40A of the New Jersey Statutes and Title 19 of the Revised Statutes.

BE IT ENACTED by the Senate and General Assembly of the State of New Jersey:

40A:11-51 1. a. A county, municipality, independent authority, board of education, or fire district is hereby authorized to establish by ordinance, resolution or regulation, as may be appropriate, measures limiting the awarding of public contracts therefrom to business entities that have made a contribution pursuant to P.L.1973, c.83 (C.19:44A-I et seq.) and limiting the contributions that the holders of a contract can make during the term of a contract, notwithstanding the provisions and parameters of sections 1 through 12 of P.L.2004, c.19 (C. 19:44A-20.2 et al.) and section 22 of P.L.1973, c.83 (C.19:44A-22).

b. The provisions of P.L.2004, c.19 shall not be construed to supersede or preempt any ordinance, resolution or regulation of a unit of local government that limits political contributions by business entities performing or seeking to perform government contracts. Any ordinance, resolution or regulation in effect on the effective date of P.L.2004, c.19 shall remain in effect and those adopted after that effective date shall be valid and enforceable.

c. An ordinance, resolution or regulation adopted or promulgated as provided in this section shall be filed with the Secretary of State.

52:34-25 2. a. Not later than 10 days prior to entering into any contract having an anticipated value in excess of \$17,500, except for a contract that is required by law to be publicly advertised for bids, a State agency, county, municipality, independent authority, board of education, or fire district shall require any business entity bidding thereon or negotiating therefor, to submit along with its bid or price quote, a list of political contributions as set forth in this subsection that are reportable by the recipient pursuant to the provisions of P.L.1973, c.83 (C.19:44A-I et seq.) and that were made by the business entity during the preceding 12 month period, along with the date and amount of each contribution and the name of the recipient of each contribution. A business entity contracting with a State agency shall disclose contributions to any State, county, or municipal committee of a political party, legislative leadership committee, candidate committee of a candidate for, or holder of, a State elective office, or any continuing political committee. A business entity contracting with a county, municipality, independent authority, other than an independent authority that is a State agency, board of education, or fire district shall disclose contributions to: any State, county, or municipal committee of a political party; any legislative leadership committee; or any candidate committee of a candidate for, or holder of, an elective office of that public entity, of that county in which that public entity is located, of another public entity within that county, or of a legislative district in which that public entity is located or, when the public entity is a county, of any legislative district which includes all or part of the county, or any continuing political committee.

The provisions of this section shall not apply to a contract when a public emergency requires the immediate delivery of goods or services.

b. When a business entity is a natural person, a contribution by that person's spouse or child, residing therewith, shall be deemed to be a contribution by the business entity. When a business entity is other than a natural person, a contribution by any person or other business entity having an interest therein shall be deemed to be a contribution by the business entity. When a business entity is other than a natural person, a contribution by: all principals, partners, officers, or directors of the business entity or their spouses; any subsidiaries directly or indirectly controlled by the business entity; or any political organization organized under section 527 of the Internal Revenue Code that is directly or indirectly controlled by the business entity, other than a candidate committee, election fund, or political party committee, shall be deemed to be a contribution by the business entity.

c. As used in this section:

"business entity" means a natural or legal person, business corporation, professional services corporation, limited liability company, partnership, limited partnership, business trust, association or any other legal commercial entity organized under the laws of this State or of any other state or foreign jurisdiction;

"interest" means the ownership or control of more than 10% of the profits or assets of a business entity or 10% of the stock in the case of a business entity that is a corporation for profit, as appropriate; and

"State agency" means any of the principal departments in the Executive Branch of the State Government, and any division, board, bureau, office, commission or other instrumentality within or created by such department, the Legislature of the State and any office, board, bureau or commission within or created by the Legislative Branch, and any independent State authority, commission, instrumentality or agency.

d. Any business entity that fails to comply with the provisions of this section shall be subject to a fine imposed by the New Jersey Election Law Enforcement Commission in an amount to be determined by the commission which may be based upon the amount that the business entity failed to report.

19:44A-20.13 3. a. Any business entity making a contribution of money or any other thing of value, including an in-kind contribution, or pledge to make a contribution of any kind to a candidate for or the holder of any public office having ultimate responsibility for the awarding of public contracts, or to a political party committee, legislative leadership committee, political committee or continuing political committee, which has received in any calendar year \$50,000 or more in the aggregate through agreements or contracts with a public entity, shall file an annual disclosure statement with the New Jersey Election Law Enforcement Commission, established pursuant to section 5 of P.L.1973, c.83 (C.19:44A-5), setting forth all such contributions made by the business entity during the 12 months prior to the reporting deadline.

b. The commission shall prescribe forms and procedures for the reporting required in subsection a. of this section which shall include, but not be limited to:

(1) the name and mailing address of the business entity making the contribution, and the amount contributed during the 12 months prior to the reporting deadline;

(2) the name of the candidate for or the holder of any public office having ultimate responsibility for the awarding of public contracts, candidate committee, joint candidates committee, political party committee, legislative leadership committee, political committee or continuing political committee receiving the contribution; and

(3) the amount of money the business entity received from the public entity through contract or agreement, the dates, and information identifying each contract or agreement and describing the goods, services or equipment provided or property sold.

c. The commission shall maintain a list of such reports for public inspection both at its office and through its Internet site.

d. When a business entity is a natural person, a contribution by that person's spouse or child, residing therewith, shall be deemed to be a contribution by the business entity. When a business entity is other than a natural person, a contribution by any person or other business entity having an interest therein shall be deemed to be a contribution by the business entity. When a business entity is other than a natural person, a contribution by: all principals, partners, officers, or directors of the business entity, or their spouses; any subsidiaries directly or indirectly controlled by the business entity; or any political organization organized under section 527 of the Internal Revenue Code that is directly or indirectly controlled by the business entity, other than a candidate committee, election fund, or political party committee, shall be deemed to be a contribution by the business entity.

As used in this section:

"business entity" means a natural or legal person, business corporation, professional services corporation, limited liability company, partnership, limited partnership, business trust, association or any other legal commercial entity organized under the laws of this State or of any other state or foreign jurisdiction; and

"interest" means the ownership or control of more than 10% of the profits or assets of a business entity or 10% of the stock in the case of a business entity that is a corporation for profit, as appropriate.

e. Any business entity that fails to comply with the provisions of this section shall be subject to a fine imposed by the New Jersey Election Law Enforcement Commission in an amount to be determined by the commission which may be based upon the amount that the business entity failed to report.

4. This act shall take effect immediately.

APPENDIX A

AMERICANS WITH DISABILITIES ACT OF 1990

Equal Opportunity for Individuals with Disability
